The members of the Consumer Healthcare Products Association (CHPA) Dietary Supplements Committee (DSC) appreciate the opportunity to submit nominees for the position of nonvoting industry representative on FDA's Food Safety Public Advisory Committee. Nominations were requested in the *Federal Register* notice published June 11, 2007 (72 *Federal Register* 32123-32124). CHPA, founded in 1881, is a national trade association representing manufacturers and distributors of dietary supplements and over-the-counter medicines. The DSC is nominating two candidates for the industry representative position on the advisory committee, both of whom are affiliated with CHPA member companies. For nearly 30 years, Dr. Burdock has utilized his toxicology expertise in the area of safety for products such as food additives, food ingredients, personal care products, and dietary supplements. In his current role, Dr. Burdock provides safety and toxicology information on food, food


